I declare that I have not been involved in any activity of indiscipline, misbehaviour or have used unfair means in examinations in the past and I have not hidden any facts regarding this act. In case I do not abide by these rules & regulations my admission from institute can be cancelled. In every case, the decision of Management/ Society will be final and binding on me and will be acceptable to me.

I certify that the information given by my son/ daughter/ ward or this admission form is true and correct. I will be solely responsible for his/ her Activities and will pay attention towards his/ her progress. My son/ daughter/ ward will fulfil the minimum attendance requirement as prescribed by university rules, failing which he/ she will be barred from taking the University examination. I will be responsible for the payment of his/ her institute fee and other dues on time. I also undertake that if my son/ daughter/ ward leaves college between the course, I will be liable to the pay complete fee of the Institute for the remaining course. I also undertake that, I will not be eligible to receive any refund of the payment of fee made by me to the institute. I undertake to repay any loss/ damage to the property of the institute made by my son/ daughter/ward and shall make good the cost of such damage/ loss immediately on demand of the same. I am aware of the law regarding ragging as a cognizable offence and shall abide by the punishment meted out to my ward in case he/ she is found guilty of ragging.

1. That we undertake, that institute fee shall be paid on time else our admission shall automatically be cancelled and fee deposited by us will be forfeited by institute.
2. That we undertake, we will abide by the rules & regulations of DAVV Higher Education and any other statutory body. Failure on this, our admission will be cancelled and we will be barred from institute and will not be allowed to sit in university exams.
3. That we undertake, that once fee is deposited, it will not be refundable to us in any case and circumstances.
4. That we undertake, to follow the fee payment schedule of college, or else we will be liable to pay late fee on the same.
5. I have understood the fee structure and payment schedule of college and I don't have any objection on it.
6. If your mobile number or address changes for some reason, then it is mandatory to inform the same immediately to the college. Due to old number or address, in any event, examination form, internal examination or enrollment information is not received from the college, then the college will not be responsible.
7. If you change your subject stream, then you will have to inform the college through a written application with the permission of Faculty Members before July 31. Otherwise, after July 31, the stream will not change in college and will be processed only according to DAVV rules.
8. As per DAVV norms attendance in classroom 75% attendance is compulsory, else candidate is not allowed to sit in University exam.
9. All legal disputes will be subject to the jurisdiction of Indore Court.
10. Any change in above information shall be informed accordingly.
11. In case of any dispute management decision would be final.
12. If the student damages the classroom or any property within the campus (like AC, Camera, Table, Board, Passages, Library Book or Material, etc.) he/ she will be charged a fine of ₹10000/- per month.
13. Shifting from international courses is not allowed. Fee of one course cannot be used to study another course.
14. If you want to leave the college please intimate the same in May/June or else entire year's fee is payable.
15. Any university form, MP online portal entry/enrolment has to be filled on time by the student or else the college will be not be responsible for the same.
16. I have understood and read the fee structure and regulations of college and that I will abide by the same.
17. VISA charges will be paid by students only and any screening / interview for visa has to be fulfilled by the students personally, bearing all charges by themselves.
18. For any delay in passport or VISA from students side, the responsibility will lie on students only and he/she will not be allowed to join the tour and his/her opportunity will be lapsed.
19. Documents and Marksheets are to be submitted on time by the students, else any cancellation by university or DTE will be the sole responsibility of the student.
20. Students opting for bus facility will continue with the year and computing eligibility criteria and all norms of college.

## General Guidelines of Foreign Tour

1. In B.Com Foreign Plus course, 1 foreign tour. BBA (ILP) total three foreign trips in 3 years.
2. Valid Passport with minimum expiry of 1 year has to be submitted till September 30th by the students.
3. VISA charges have to be paid by the student. If in case Visa is not issued due to student's document or requirements then student will be responsible.
4. Annual fee payable by the student is inclusive of all and Foreign tour is a part of the fee structure leaving exclusion.
5. Foreign tour is fixed, no change will be done for the destination as decided by the management.
6. With student's consent and management's permission, if tour covers additional destination then extra charges will be borne by the student.
7. All tours are Ex Delhi, Mumbai, Chennai etc. Students have to reach these cities by their own.
8. Foreign tour in all courses is free with fee, so no application for refund will be entertained.
9. Time duration and month of the foreign tour is fixed by the management which will be final.
10. If any student is leaving the course in between he/she will not remain eligible for the foreign tour.
11. Any student not continuing the course next year will have to notify the same till March, else fee for next year fees will be payable.
12. Medical certificate, Covid Vaccination certificate, RTPCR & NOC are mandatory for traveling while on foreign education trips.
13. Any additional charges like vaccination or any related protocol by govt. will be borne by the student.
14. If you miss any tour for any reason that tour will be lapsed and no other chance will be given.
15. If you want to leave the college then intimate in May/June or else complete year fee is payable.
